All prices quoted in these T&amp;Cs are inclusive of GST.</li> <li>4. The Gift is not transferable or redeemable for cash and may be claimed only by the Eligible Claimant whose name is stated on the proof of purchase. All Eligible Claims must be carried out by the actual purchaser of the Participating Products. Claims by any other person will not be accepted.</li> <li>5.
